### DISCUSSION / BACKGROUND

The Secretary of State has made \$17,000 available in the Help America Vote Act (HAVA) grant funds for attendance at Department of Rehabilitation (DOR) regional training sessions and for polling place improvements and equipment necessary to implement the HAVA Section 261 requirement.

The Elections Department will use the grant funds to attend DOR training, update accessibility surveys for polling places to be used in 2015 and 2016 elections and purchase equipment to improve polling place accessibility.
