Background

Request to consider Special Use Permit Revision S01-0032-R-6/American Tower Corporation Strawberry Site submitted by AMERICAN TOWER CORPORATION (Agent: Bell & Associates/Gordon Bell) to allow the conversion of the existing 125-foot tall monopine to a 120-foot monopole by removing the existing branches. The monopole will remain a dark brown color and monopine bark will remain. All existing antennas and mounting hardware will be painted to match the existing bark. The property, identified by Assessor's Parcel Number 038-400-19, consisting of 14.71 acres, is located at the east end of Cooks Spur Road, approximately 0.23 mile north of the intersection with Short Hill Road, in the Strawberry area, Supervisorial District 2.
