# **DISCUSSION / BACKGROUND**

The contract for the Lake Tahoe Blvd Erosion Control/Stream Environment Zone Project (Project) was approved by the Board on July 28, 2015. Construction was substantially completed on October 12, 2015. Recordation of the Notice of Acceptance will start legal time frames for guarantees, a lien period and return of retention monies. Recordation of the Notice of Acceptance will also start the one -year time frame for releasing the Payment and Performance Bonds to the Surety.

One Major Contract Change Order on the Project dealt with the following:

• CCO #1 - Contract items over 125% of the original contract quantity (additional material costs for paving and aggregate base shouldering).

The costs listed are estimates. Transportation will be closing out the Project with the Contractor and finalizing costs over the coming weeks. Any significant deviations from the estimates above that exceed Transportation's allocated authority will be brought back for the Board for review and approval in a subsequent agenda item.
