#### **DISCUSSION / BACKGROUND**

The contract for the Tahoe Hills Erosion Control Project (Project) was approved by the Board on August 7, 2015. Construction was substantially completed on September 21, 2015. Recordation of the Notice of Acceptance will start legal time frames for guarantees, a lien period and return of retention monies. Recordation of the Notice of Acceptance will also start the one-year time frame for releasing the Payment and Performance Bonds to the Surety.

Direct Construction Cost Summary:

Original Bid Price	\$ 327,824.50
Contract Item Cost	\$ 325,316.50
Contract Change Order Cost	\$ 4,074.00
Total Direct Construction Cost	\$ 329,390.50
Direct Construction Budget	\$ 345,000.00

Major Contract Change Orders (CCO) on the Project dealt with the following:

- CCO#1 Fracture and removal of rock that was affecting the installation of planned improvements.
- CCO#2 Modified five corrugated steel pipe inlets by lowering the rim elevations to match existing surface elevations.

The costs listed are estimates. Transportation will be closing out the Project with the Contractor and finalizing costs over the coming weeks. Any significant deviations from the estimates above that exceed Transportation's allocated authority will be brought back for the Board for review and approval in a subsequent agenda item.
