Procurement and Contracts has been advised that funding is available within the Community Development Agency - Transportation Division - Fleet Unit's budget and Federal issued grants through AQMD.

Reason for Recommendation

At the request of Community Development Agency - Transportation Division - Fleet Unit, the Procurement and Contracts division issued an Invitation to Bid for six (6) new 2016 Ford C-Max Plug-In Energi, Hybrid 4-Door Sedans vehicles. The replacement of fleet vehicles is generally determined when the vehicle reaches the targeted mileage standardized by Fleet Management, or replaced due to accidents in which the vehicle could not be repaired. All Vehicle replacements are in accordance with the revised Vehicle Standards approved by the Board of Supervisors on April 4, 2011

One (1) vehicle type was included in the bid solicitation, eight invitations to bid were mailed, two responses were received, none from local vendors as there are no local vendors for this solicitation in El Dorado County.
