DISCUSSION / BACKGROUND

From November 10 through 13, 2015 the Board considered the Targeted General Plan Amendment and Zoning Ordinance Update (TGPA-ZOU). At that time, tentative motions were made directing staff to return to the Board on December 15, 2015 with any pertinent and relevant information for the final approval of the Targeted General Plan Amendment and Zoning Ordinance Update.
