2) Approve and authorize the Clerk of the Board to release the Payment and Performance Bonds to the Surety upon notification from Transportation after the one-year guarantee period.

DISCUSSION / BACKGROUND

The contract for the Project was approved by the Board on July 21, 2015, item number 11. Construction was substantially completed on November 20, 2015. Recordation of the Notice of Acceptance will start legal time frames for guarantees, a lien period, and return of retention monies. Recordation of the Notice of Acceptance will also start the one-year time frame for releasing the Payment and Performance Bonds to the Surety.

Direct Construction Cost Summary:

Original Bid Price	\$ 172,582.57
Contract Item Cost	\$ 171,926.93
Contract Change Order Cost	\$ 13,674.02
Total Direct Construction Cost	\$ 185,600.95
Direct Construction Budget	\$ 192,700.00

The contract change order cost includes supplemental items.

Major Contract Change Orders on the Project dealt with the following:

- Decreasing the number of pull boxes, revising the location of the Pedestrian Push Button, and revising the location of signal pole E.
- Replacing existing signal pole “b” and two pull boxes due to a vehicle accident.
- Adding two regulatory signs to the Project.

The final costs listed are estimates. Transportation will be closing out the Project with the Contractor and finalizing costs over the coming weeks. Any significant deviations from the estimates above that exceed Transportation’s allocated authority will be brought back to the Board for review and approval in a subsequent agenda item.

FINANCIAL IMPACT

There is no change to Net County Cost associated with this item. Funding for the Project is budgeted in the adopted 2015 Capital Improvement Program and is provided by the Highway Safety Improvement Program and Regional Surface Transportation Program Match Funds - Caltrans. The anticipated direct construction cost is less than the direct construction budget established by the Board.
