The County Surveyor's Office received an application from EL DORADO IRRIGATION DISTRICT, for an Irrevocable Offer of Dedication (IOD 15-006), for drainage easements in support of the Carson Crossing Zone of Benefit and the Carson Creek Specific Plan. EID inadvertently recorded the IOD prior to the consent from EI Dorado County. The IOD needs to be re-recorded with a correctory cover sheet attached to the front and a consent to the offer attached to the back.
