DISCUSSION BACKGROUND:

The County Surveyor's Office received a request from **Community Development Agency, Transportation Division** to process an Irrevocable Offer of Dedication (IOD 16-001), for a road right-of-way in fee and a Public Utility Easement located on and identified as Assessor's Parcel Numbers 121-210-03 and 121-210-04. The offer was made by SERRANO ASSOCIATES LLC, A DELAWARE LIMITED LIABILITY COMPANY. *IRREVOCABLE OFFER OF DEDICATION ROAD RIGHT OF WAY AND PUBLIC UTILITIES EASEMENT* was signed, February 1, 2016. This offer is in support of the El Dorado Hills Specific Plan - Bike Trail Project, and is a portion of Silva Valley Parkway.
