REASON FOR RECOMMENDATION: At the request of Human Services, Community Services Division, the Procurement and Contracts Division issued a Request for Proposal for hiring a qualified individual or firm to provide Workforce Investment Activities Rapid Response funding allocation to assist the County to guide, support, and strengthen businesses in both El Dorado and Alpine Counties through the Golden Sierra Workforce Investment Activities under 20 CFR 665. The activities have the following main objectives: register laid off workers with higher skills into the one-stop system; assist laid off workers with obtaining jobs and re-entry into the labor force; and build the inventory of skilled workers in our system thereby offering greater value to the business community.

The Board is being asked to make findings that is more economical and feasible to obtain an outside contactor to furnish these services since the County does not have the staff with the special skills and qualifications necessary to perform the work and the nature of the work is temporary and does not warrant hiring full-time staff.

Ten (10) Request for Proposals were mailed. One (1) qualified response was received. After review and evaluation of the proposal criteria, Human Services, Community Services Division has determined El Dorado JOB ONE's proposal to be the sole, qualified respondent. The proposal was evaluated on the basis of project summary; agency background information and direct services provided; program design; projected program objectives, activities, time schedule; client data tracking; and program budget.

FISCAL IMPACT/CHANGE TO NET COUNTY COST: Procurement and Contracts has been advised that funding is available within the Human Services, Community Services Division's budget through Work Force Investment Activities Rapid Response allocation.

ACTION TO BE TAKEN FOLLOWING APPROVAL: Following Board approval, County Clerk's Office will forward executed Agreement to Procurement and Contracts for distribution and encumbrance as needed.
