(4/5 vote required)

Fiscal Impact/Change to Net County Cost: In-kind match of \$234,087

Background: On October 31, 2006, the Board approved the Sheriff's request to submit to the Corrections Standards Authority (CSA) the Mentally Ill Offender Crime Reduction Grant Application. On 1/9/07 the Board approved Resolution #006-2007 agreeing to the specifications of the grant.

Reason for Recommendation: The fully executed grant award has been received from the Corrections Standards Authority and is being submitted for Board approval. Also included in this agenda item are the increased staffing allocations for the Probation and Mental Health departments as well as a budget transfer that is necessary to establish revenue and expenditure appropriations in the Sheriff, Mental Health and Probation budgets for this grant.

Action to be taken following Board approval: Staffing allocations will be increased by Human Resources for the Mental Health and Probation departments, the Auditor will process the budget transfer establishing revenue and expenditure appropriations in the Sheriff, Mental Health and Probation budgets.
