In accordance with Board of Supervisors Policy C-17, Sections 7.5 and 7.10, the Purchasing Agent concurs that it is appropriate to contract with Sacramento County for the provision of access to confidential California Law Enforcement Telecommunications Systems contained within the Sacramento County Criminal Justice Information System. The County Sheriff's Office, District Attorney's Office, Probation, and Human Services are authorized users of the various criminal databases available through Sacramento County. In the early 1990's the county attempted to develop interfaces with the Sacramento County Office of Communications and Information Technology, but it was determined that it would be too costly to implement. The Information retworks. Therefore; the Purchasing Agent has determined that the nature of the services precludes the need for a competitive selection process. The services provided by Sacramento County are successfully utilized by multiple other California jurisdictions.
