The Department of Transportation has received an Irrevocable Offer of Dedication for a drainage easement, located across the rear portion of Lot 116 of Pioneer Place Unit 1, identified as Assessor's

Parcel Number 115-390-11, and being more particularly described in Exhibit "A" and depicted in Exhibit "B" of the attached Resolution. Said dedication is being made by Neil P.
