Fiscal Impact/Change to Net County Cost: The Department of Human Services has advised General Services that funds are included in their FY2007-08 budget request.

Background: The County of El Dorado has leased this facility since October 27, 1998 for the Department of Human Services, Job One Program.

Reason for Recommendation: The current facility lease agreement expires on June 30, 2007 and the Department of Human Services has expressed their desire to exercise the option to extend the lease for an additional one (1) year term commencing July 1, 2007 and ending on June 30, 2008. The lease amount is \$3,112.70 per month at a cost of \$1.70 per square foot. This lease is retroactive to July 1, 2007.

Action to be taken following Board approval: Upon approval by the Board, General Services will forward the official notification to the Lessor.
