**REASON FOR RECOMMENDATION**: At the request of the General Services Department, Parks and Grounds Division, the Procurement and Contracts Division issued a Request for Qualifications and Statement of Interest (RFQ) for the pupose of hiring a professional consulting firm to provide landscape architecture and civil engineering services for the proposed 26.4 acre Community Park in Pollock Pines.

Your Board is being asked to make findings that is is more economical and feasible to contract out the needed work in accordance with County Ordinance Chapter 3.13 as the General Services Department does not possess the trained personnel to perform the design and engineering work.
