Fiscal Impact/Change to Net County Cost: No change. Funds are budgeted for FY 2007/08.

Background: The El Dorado County SB 163 Wraparound Program was established in 2001. On February 28, 2006, the Board of Supervisors approved a proposal to transfer administrative

responsibility for this Program to the Department of Human Services and allow for expansion of services. The Program provides services to youth in or at risk of group home placement, at risk of being placed in higher levels of care, or at risk of losing their local residence with the goal of reducing the number of youth in higher level placements. An array of treatment and intervention services are provided in accordance with provisions of the current El Dorado County Wraparound Program Plan approved by the Board of Supervisors on September 26, 2006. These services are designed to reduce the number of children placed in out-of-county and/or group homes.

**Reason for Recommendation:** The Department of Human Services (DHS) receives an annual State funding allocation for the implementation and management of Senate Bill 163 Wraparound Program services. DHS and the Department of Mental Health provide Wraparound Program services to eligible children and their families. MOU #032-M0811 delineates the responsibilities of each Department in the provision of these services.

The Purchasing Agent concurs that this memorandum of understanding is in compliance with Board of Supervisors Policy C-17, Sections 7.5 and 7.10. Outside review of contractor's ability to perform the needed services is not required as the Department of Human Services and the Mental Health Department are departments of El Dorado County.

**Action to be taken following Board approval:** Board Clerk to forward two (2) originals of the executed Memorandum of Understanding #032-M0811 to Procurement and Contracts. Auditors Office to authorize payment of future invoices.
