Background: On October 18, 2005 the Board of Supervisors authorized the Chairman to sign Resolution #306-2005 approving a contract with the Secretary of State for distribution of \$18,798.57 in HAVA Section 261 federal grant funding.

El Dorado County has utilized \$6,793.42 of the \$18,798.57 originally awarded.

Reason for Recommendation: Due to the change in dollar amount, the Secretary of State has issued a new contract for the remaining \$12,005.15 available, and requested a new Resolution reflecting approval of this change.

Action to be taken following Board approval: Resolution will be forwarded to Secretary of State and execution of the agreement will commence.
