Fiscal Impact/Change to Net County Cost: Funding is included in Public Health's FY 2007/08 Alcohol/Drug Treatment budget. There is no Net County Cost.

Background: The Public Health Department, in collaboration with the Department of Human Services and the El Dorado County Superior Court, oversees the Dependency Drug Court Program which provides treatment for parents whose substance abuse contributes to child abuse and/or neglect resulting in involvement with juvenile court dependency proceedings. Funding for this program is

provided by a CDCI Agreement from the California Department of Alcohol and Drug Programs.

Reason for Recommendation: The attached Agreement provides funding in the amount of \$102,954 for the Dependency Drug Court Program for FY 07/08. This Agreement is retroactive to July 1, 2007 due to late receipt of grant documents from the State.
