Fiscal Impact/Change to Net County Cost: There is no increase in net County cost and therefore does not affect the Development Services Department budget.

Background: On February 5, 2008, the Board of Supervisors adopted Resolution 25-2008 establishing the membership and setting forth the responsibilities of the Building Industry Advisory Committee (BIAC). In the interim, Development Services has received a request for a change to the representatives of the El Dorado Builders Exchange and subsequently received a request for an appointment "at large".

Reason for Recommendation: The reaffirmation of appointees on February 5, 2008 and requested changes and additions to the BIAC will allow the committee to focus on policies and procedures related to the building industry.

Action to be taken following Board approval: Upon reaffirmation and approval of the representatives, the Development Services Department will contact the affected agencies and appointed member. The Notice of Vacancy will be changed to indicate one "at large" vacancy with two alternate vacancies. Upon receipt of interest, Development Services will request the Board of Supervisors appoint the interested persons to the BIAC to complete the formation of the committee.
