Fiscal Impact/Change to Net County Cost: No change.

The amount of federal funds payable by the State to El Dorado County under this Contract remains \$1,018,753. The funding balance under this Contract was budgeted for FY 2007/08, and any unspent funds will be included in the FY 2008/09 County Budget Request.

Reason for Recommendation:

The Board initially executed Contract #06B-5358 on January 10, 2006 in the amount of \$58,704 for provision of LIHEAP services during the term January 1, 2006 through December 31, 2006. Amendments 1 and 2 increased the maximum funding level to \$1,018,753 and extended the term to December 31, 2007. Amendment 3 to Contract #06B-5358 extends the contract term through December 31, 2008 to allow for full expenditure of the 2006 funding. LIHEAP services have historically been in great demand, and high energy costs render them even more critical to the many frail, vulnerable residents on fixed incomes. County Counsel and Risk Management have approved the contract Amendment, which is attached and on file with the Board Clerk.

Action to be taken following Board approval:

Board Clerk to provide Human Services, Community Services Division, with four copies of Amendment 3 to LIHEAP Contract #06B-5358 signed by Chairman and three Certified Resolutions.
