Anova Architects is familiar with the facility being remodeled and is uniquely qualified to provide design, project management and construction management services with minimal disruption of the Sheriff's operations. Additionally, Anova Architects will stage their work in conjunction with the Sheriff's employees redeployment to leased space.
