Fiscal Impact/Change to Net County Cost: Funding has been included in the FY 2008-09 proposed budget for these agreements.

#### Reason for Recommendation:

County Counsel conducted meetings in both Placerville and South Lake Tahoe with the Attorneys and Judges to discuss how the process has been working and current economic conditions.
