Background:

Reason for Recommendation:

The Department of Transportation has received an Irrevocable Offer of Dedication for road right of way and public utilities easement, situated on Assessor's Parcel Number 054-391-18, being more particularly described in Exhibit A and depicted in Exhibit B of the attached Resolution. Said

dedication is being made by Ann Marie Salch and Carl G. Salch, and is necessary to meet the condition requirements of DR07-0004. The subject property location lies just north of Pleasant Valley Road and east of Odd Fellows Road in Diamond Springs.

The Department of Transportation's staff has reviewed said offer and recommends that the Board adopt and authorize the Chairman to sign the Resolution acknowledging but rejecting said offer for road right of way and public utilities easement at this time. Authorization for recording of said offer is pursuant to Government Code Section 7050.
