Fiscal Impact/Change to Net County Cost: It is proposed to utilize \$1,750 of the Department's County General Fund dollars budgeted for that purpose to meet the cash match requirement if the application is funded.

### Background:

#### Reason for Recommendation:

On August 16, 2007, the EI Dorado County Office of Economic Development held a forum in the Georgetown Divide community to discuss barriers to community and economic development specific to that area. Community and County stakeholder groups subsequently formed to assess concerns that were identified at the forum. The overall goal of the stakeholders is to identify methods to stimulate private sector investment and sustainable economic development growth in the identified business sectors of destination, recreation, equine, bed and breakfast, and outdoor backpacking. Submittal of an application to the State Department of Housing and Community Development to obtain a Community Development Block Grant Economic Development Planning and Technical Assistance Allocation of up to \$35,000 will allow the County to hire a consultant to: collect and evaluate socio-economic and demographic datasets; develop a community stakeholders and resources map; and identify key community and industry sector drivers of the economy. The results will be an Economic Development Plan that the Georgetown Divide community can use as a foundation to plan future business retention and expansion and attraction activities resulting in sustainable economic growth for this rural economy. The Resolution, Application, Public Hearing Notice, NOFA and Statement of Assurances are attached and on file with the Board Clerk.

#### Action to be taken following Board approval:

Board Clerk to provide Human Services, Community Services Division, with three (3) certified resolutions and three (3) Statement of Assurances signed by the Chairman.

Human Services to submit the Community Development Block Grant Economic Development Allocation Planning and Technical Assistance Application to the California Department of Housing and Community Development.
