Transportation Department recommending the Board authorize the Chairman to sign the First Amendment to Funding Agreement AGMT 07-1491 with the El Dorado County Transportation Commission for the Camino Area Corridor Project Study Report, subsequent to review and approval by County Counsel, which amends the Agreement to extend the expiration date from November 5, 2009 to February 26, 2010, and acknowledges a change in the County Officer or employee named as Contract Administrator.

**FUNDING:** 2004 General Plan Highway 50 Traffic Impact Mitigation Fee Program.

Fiscal Impact/Change to Net County Cost: There is no net cost to the County General Fund. Funding support for the Camino Area Corridor Project Study Report (PSR) is provided in the approved program budget, identified as Project No. 71319.

Reason for Recommendation: On November 6, 2007, your Board approved Funding Agreement AGMT #07-1491 (Funding Agreement) with the El Dorado County Transportation Commission (EDCTC) to help fund over a two-year period the preparation of the PSR, in the amount equal to the cost of the work performed by the selected consultant or the not-to-exceed amount of \$250,000, whichever is less.

The study effort was to be accomplished through a combination of EDCTC resources and the hiring of a planning consultant. EDCTC, as lead agency, completed a RFP process from which CH2M Hill was selected. El Dorado County Department of Transportation has been providing oversight and

guidance in this study effort as a member of the PSR's Technical Advisory Committee.

Recently, EDCTC extended the term of their planning consultant contract with CH2M Hill to December 31, 2009, in order to allow for the State of California Department of Transportation (Caltrans) to review and approve the Final PSR. By extending the expiration date of the Funding Agreement to February 26, 2010, EDCTC will have sufficient time to confirm all deliverables have been received and to submit its request to the County for reimbursement of final expenses, up to the not-to-exceed amount allowed by this Funding Agreement.

**Concurrences:**

Transportation staff has prepared and submitted the proposed First Amendment to the Funding Agreement to County Counsel's office for review and approval.

**Action to be taken following Board approval:**

1. The Chairman will sign two (2) originals of First Amendment to Funding Agreement # 07-1491, subsequent to review and approval by County Counsel.
2. The Board Clerk will forward one (1) original of the fully executed First Amendment to the Department for further processing.
