Fiscal Impact/Change to Net County Cost: Funding is provided by the OTP. This Amendment shall increase the current contract amount by \$20,000, bringing the total not to exceed amount from \$75,000 to \$95,000. This amount has been included in the adopted FY 2007-08 budget and must be

spent no later than November 30, 2007.

Background: El Dorado County was awarded funding from the California Department of Alcohol and Drug Programs in support of the OTP in El Dorado County. OTP funds are used by El Dorado County's Prop 36 Program to do the following:

- Increase the treatment allocation for residential services for offenders assessed to need them
- Increase the proportion of sentenced offenders who enter and complete treatment by offering structured relapse prevention services
- Support the County's recently implemented drug court model, including dedicated court calendars with regularly scheduled reviews of treatment progress, and strong collaboration by the courts, probation, and treatment.

Reason for Recommendation: Funding will be used to increase the availability and duration of residential services to clients who are typically repeat offenders and who need additional or enhanced treatment and counseling services.

Additionally, staff identified a discrepancy in the agenda item presented to the Board when the original contract was approved and signed. The original contract signed by the Chairman defined a not to exceed compensation amount of \$75,000. However, the item, when presented to the Board, described two conflicting amounts, one for \$30,000 and the other for \$75,000. The Department would like to clarify that the total amount of the original contract was \$75,000 for the term ending November 30, 2007.

Action to be taken following Board approval: Chairman to sign three (3) copies of attached amendment with Progress House, Inc.; Board Clerk's Office to return two (2) signed copies to Public Health; and Public Health to distribute amendment as appropriate;
