DISCUSSION / BACKGROUND

The Parks Division was contacted by Claire Inzano, Kristi Wyles and Jacqueline Conway with

requests to either donate a park bench or repair an existing park bench. The new park bench would be installed at Henningsen Lotus Park in the Coloma-Lotus Valley and the repaired benches are along the Class I El Dorado Trail east of the Jacquier Rd trailhead. Staff provided costs associated with the purchase and installation of the bench as well as the cost of the materials and labor to replace the boards on the existing benches. Those costs were as follows:

Park Bench	\$345.00
Shipping	\$140.00
3 hrs of Facilities staff labor at \$75.00/hr	\$225.00
Concrete	\$ 40.00
Total	\$750.00

Replacement of Boards on existing twp benches

Lumber, Hardware \$500.00 4 hrs of Facilities staff labor at \$75.00/hr \$300.00 Total \$800.00

Staff has completed a draft donation policy to accept donations such as these and will present it to the Board for consideration at a later date.
