BACKGROUND

Request to consider Tentative Subdivision Map Time Extension TM05-1395-E/La Caille Estates submitted by Orbis Financial (Agent: CTA Engineering & Surveying) for three one-year time extensions to the approved La Caille Tentative Subdivision Map TM05-1395 creating 24 residential lots, resulting in a new expiration date of November 14, 2019. The property, identified by Assessor's Parcel Numbers 070-510-01, 070-510-02, 070-510-03, and 070-510-04, consisting of 25.04 acres, is located on the south side of Meder Road, approximately 0.5 mile west of the intersection with Ponderosa Road, in the Shingle Springs area, Supervisorial District 4.
