DEPARTMENT RECOMMENDATION

Probation Department recommending the Board authorizes the Chair to sign Amendment II to Agreement 045-S1610 with Noble Software Group, LLC increasing the contract by \$6,546. The increase will cover the Noble View Hosting Fee for years two and three. The \$7,000 credit toward the final six months of the Adult Assessment software is to document the verbal agreement that the use of the Adult Assessment software would be included free of charge for the first year of use. not to exceed amount now totals \$91,546.00.

DISCUSSION / BACKGROUND

Over the last several years the state has been moving towards evidence based practices as the standard for programs and services. The Probation Department has procured the services of NOBLE Software, Inc. for juvenile and adult risk assessments using DRAI, PACT and PACT-pre assessment tools, and SRNA (Static Risk and Needs Assessment) tool for adults, all of which are evidence based. The addition of the Noble View software will be used for data collection and reporting requirements.
