#### **DISCUSSION / BACKGROUND**

Mapes Enterprises has been contracted by the County to perform snow removal and snow staking services for various County operated facilities in the South Lake Tahoe basin. The contractor services County facility parking lots, driveways, sidewalks and walkways to ensure access to County facilities.

With the snowfall in South Lake Tahoe far above recent averages this season, additional compensation is required so that Contractor's services may be retained for the duration of winter. Recent data indicates the snow pack level is the largest in 22 years and more is expected through these remaining months. The Amendment provides additional compensation in the event it is needed, alters the payment terms to bi-monthly, provides Saturday and Sunday services for the Animal Shelter and incorporates snow hauling services in the occasion County Transportation Division is unable to do so in a timely manner.

#### **ALTERNATIVES**

Without the Amendment it's very likely the County will deplete the compensation available prior to the end of the winter season due to the extraordinary amount of snowfall received thus far. This will result in County facilities not being accessible for employees or the public as parking areas will not be plowed.
