DEPARTMENT RECOMMENDATION:

The Health and Human Services Agency (HHSA), Public Health Division wishes to provide the Board with an update on the status of the "Healthy Living Parklet Design Competition" sponsored by Public Health, along with development and installation of the Parklet.

DISCUSSION / BACKGROUND:

On December 13, 2016, the Board received a presentation outlining the plan for use of a \$10,000 award from the Health Officers Association of California for the Communications Award for "Most Innovative Campaign in a Small Jurisdiction." (Item 16-0762) to create and install a Parklet in the City of Placerville.

Public Health solicited designs from local high school students for the "Healthy Living Parklet Design Competition," and after much deliberation selected the "Main Street Parklet" submitted by Emily Bobrowsky from Oak Ridge High School.
