Title: Health and Human Services Agency (HHSA), recommending the Board:

> 1) Approve the continuation of twenty-two (22) perpetual agreements as detailed in Attachment 7A; 2) Authorize the Purchasing Agent, or designee, to establish blanket purchase orders, as needed, for those approved perpetual agreements, to process associated payments for Fiscal Year 2017 /18;

3) Delegate authority to the HHSA Director to execute amendments, if any, to the perpetual

agreements detailed in Attachment 7A as needed, including amendments, which do not increase the maximum dollar amount or change the term of the Agreement, and contingent upon approval by County Counsel and Risk Management, and notify the Board of such amendments on an annual

basis;

4) Receive and file the list of terminated perpetual agreements detailed in Attachment 7B; and

5) Authorize the HHSA Director to terminate other perpetual agreements as appropriate and notify the

Board of such terminations on an annual basis.
