Title: Community Development Services, Transportation Department, recommending the Board consider

the following:

1) Accept the subdivision improvements for West Valley Village, Unit 5A (TM99-1359-5A), as

complete;

2) Retain Performance Bond Rider 2 (Bond 948902) in the amount of \$594,758.02, which is ten percent (10%) of the revised total cost of the subdivision improvements. This amount guarantees against any defective work, labor done, or defective materials furnished, which is to be released after

one (1) year if no claims are made;

3) Hold Laborers & Materialmens Bond Rider 1 (Bond 94-89-02) in the amount of \$2,973,790.11 for six (6) months to guarantee payments to persons furnishing labor, materials, or equipment; and 4) Authorize the Clerk of the Board to release the respective Bonds after the required time periods.
