### DISCUSSION / BACKGROUND

The Sheriff's Office and the Probation Department have had an agreement with Madeira Group International for several years to provide "as-needed" background investigative services for new hires. This agreement is to continue receiving these services for a new three-year contract term. The agreement is retroactive to August 4, 2017, in order to avoid an interruption in services following the expiration of the last agreement.

### ALTERNATIVES

Failure to approve this contract would result in the inability of the Sheriff's Office and Probation Department to utilize these essential services.
