#### DEPARTMENT RECOMMENDATION

Surveyor's Office recommending the Board:

- 1) Acknowledge and approve an Irrevocable Offer of Dedication (IOD) for a public service easement on Assessor's Parcel Number 119-100-53 to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution.
- 2) Authorize the Chair to sign the Consent to the Making of an Irrevocable Offer of Dedication for Public Service Easements and to record the Irrevocable Offer of Dedication with the Consent attached. Authorization for recording said Offer is pursuant to Government Code Section 7050.

#### **DISCUSSION / BACKGROUND**

The Surveyor's Office received an application from El Dorado Hills Community Services District, A Public Agency, for a public service easement on Assessor's Parcel Number 119-100-53, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This IOD is in support of the Bass Lake Specific Plan.
