## Resolution 139-2010

Fiscal Impact/Change to Net County Cost: None. There is no net cost to the County General Fund associated with this agenda item.

## Reason for Recommendation:

An Irrevocable Offer of Dedication for a road right of way, including the underlying fee, to the County of El Dorado has been submitted to the Department of Transportation by Pleasant Oak Baptist Church. Said right of way is located along Pleasant Valley Road, on the property identified as Assessor's Parcel Number 098-160-03, and being more particularly described and depicted in Exhibits A and B. attached to said offer.

Said offer is necessary in order to satisfy a condition of approval of Special Use Permit #S88-41 and #S90-06. Said offer is irrevocable and runs with the land. The Department of Transportation has reviewed said offer and recommends that the Board adopt the Resolution accepting said offer, at this time.
