Fiscal Impact/Change to Net County Cost:

The attached claims totaling \$327,864 is a portion of the total TDA funds required for the program.

TDA funds in the amount of \$419,267 have been included in the FY 2007/2008 budget. The allocated TDA funds in addition to passenger fares and a Federal Transit Assistance grant will provide the total funding required to operate the existing South Lake Tahoe Transit program. A subsequent claim in the amount of \$91,403 will be brought to your Board for approval in the future to provide full funding for the program. There is no net county cost associated with this agenda item.

Reason for Recommendation:

Annually the TRPA allocates TDA funds to El Dorado County. The TDA consists of two sources of funds: the LTF and the STA. The purpose of these funds is to provide public transportation within the unincorporated area of the Tahoe Basin.

In FY 2003/2004 through FY 2006/2007 the TDA funds available to El Dorado County exceeded the amount of the TDA claims submitted to TRPA for those years due to revised allocations and an increase in estimated carryover funds made available. The amount of funds held in the County's TDA account available for appropriation to the South Lake Tahoe Transit program is \$327,864.

Section 6630 of the TDA regulations requires that a claim be filed with the local transportation planning agency to receive funds from the LTF and Section 6732 of the TDA regulations requires that a claim be filed to receive funds from the STA Fund. The TRPA requires a resolution by your Board authorizing DOT to submit said claims. DOT proposes to use these funds to operate the South Lake Tahoe Transit program, which provides public transit services in the unincorporated area of the Tahoe Basin for seniors, the disabled, and the general public.

Action to be taken following Board approval:

Upon approval of the recommendations, DOT will submit the signed claims for LTF and STA funds to the TRPA for approval by their Board.
