## DISCUSSION / BACKGROUND

Request to consider Conditional Use Permit S17-0009/Heritage Carson Creek The Retreat Clubhouse submitted by Lennar Homes of California for the construction and operation of 9,998 square foot clubhouse with a 2,000 square foot multi-purpose outdoor patio area. The recreational facility includes an on-site parking, community garden, and an Olympic swimming pool. The property, identified by Assessor's Parcel Number 117-680-10, consisting of 2.74 acres, is located south of Carson Crossing Road at the intersection with the future private subdivision road (Palmdale Drive), in the El Dorado Hills area, Supervisorial District 2.
