Background: The State of California Department of Boating & Waterways provides the Sheriff with an annual grant for an intervention program on the County's lakes and waterways. As an extension of that program, the State also offers equipment grants for items above-and-beyond the cost of the day-to-day boating operation.

Reason for Recommendation: The Sheriff has requested, and the State Department of Boating & Waterways has agreed to fund \$5,000 for the replacement and upgrade of the axels on one of the State owned boat trailers as well as the purchase of \$25,000 worth of AGA dive masks with communication technology.

Action to be taken following Board approval: The Sheriff will sign the Equipment and Operations Contract for submission to the State Department of Boating & Waterways. The Sheriff will provide Procurements & Contracts with the specifications for the requested equipment and repairs and the Sheriff's fixed asset list for FY08-09 will be updated to include eleven (11) dive masks. The Board will approve the attached Budget Transfer Request and the Auditor will post it.
