REASON FOR RECOMMENDATION: At the request of the Department of Transportation, the

Procurement and Contracts division issued an Invitation to Bid for Motor Graders to replace older graders that are not in compliance with air resources board diesel particulate standards. Forty eight (48) invitations to bid were mailed, one to a local vendor. Two (2) qualified responses were received, none by a local vendor. An evaluation spreadsheet is attached for your review.

The purchase of these motor graders is part of DOT's effort to "green the fleet" bringing our equipment fleet into compliance with new Federal and State air quality regulations. Full compliance with these regulations is estimated to cost the County approximately \$3.7 million over the next 10 years and is considered an "unfunded mandate". DOT has budgeted approximately \$2 million in FY 2008-09 to perform diesel engine retrofits and equipment replacements. Of this amount, approximately \$700,000 is being funded with Road Fund discretionary sources to match approximately \$1.3 million of grant funding.

FISCAL IMPACT/CHANGE TO NET COUNTY COST: Procurement and Contracts has been advised that funding is available within the Department of Transportation's budget. Grant Funding from Air Resources Board in the amount of \$ 198,000.00 with remaining funding (\$397,344.75) coming from the Road Fund for the two (2) Motor Graders.

ACTION TO BE TAKEN FOLLOWING APPROVAL: Following Board approval, the Procurement and Contracts division will issue a purchase order in the amount of \$595,344.75 for two (2) Motor Graders to Pape Machinery, Inc. of Sacramento.
