# **DEPARTMENT RECOMMENDATION**

Surveyor's Office recommending the Board adopt a Resolution of Vacation for Abandonment of Easement (AOE) 18-003 to abandon a public utility easement on Lot 164 of "Oak Tree Village - No. 4", recorded at Book G of Subdivisions at Page 113, identified as Assessor's Parcel Number (APN) 125-625-01, requested by the owners, Daniel S. Tiedeman and Karen T. Tiedeman Trustees of the Daniel and Karen Tiedeman Family Trust, Dated January 28, 2016.

# **DISCUSSION / BACKGROUND**

A request has been submitted by Daniel S. Tiedeman and Karen T. Tiedeman Trustees of the Daniel and Karen Tiedeman Family Trust, Dated January 28, 2016, owner of APN 125-625-01, requesting that the County of El Dorado, Board of Supervisors, vacate a public utility easement located on the subject property. Said easement is more particularly described in Exhibit A, and depicted on Exhibit B of the attached Resolution.

The public utility easement, as shown on Lot 164 of "Oak Tree Village - No. 4", recorded at Book G of Subdivisions at Page 113 was offered to the County of El Dorado by, *Oak Tree Village Joint Ventures, a California General Partnership*, on June 22, 1988. The easement was acknowledged and accepted by the County of El Dorado on October 18, 1988 and the Subdivision Map recorded on October 20, 1988.

# **ALTERNATIVES**

An alternative would be to not adopt a Resolution of Vacation for Abandonment of Easement 18-003. By utilizing this alternative, the owner of Assessor's Parcel 125-625-01, would be unable to purse any development that would impact this easement.
