DISCUSSION / BACKGROUND

At their meeting April 10, 2018 the Board of Supervisors considered an appeal from the owners of Villa Florentina Bed Breakfast and after closing the public hearing took the following action:

Supervisor Ranalli opened the public hearing and at the conclusion of the public comment period, closed the public hearing. A motion was made by Supervisor Veerkamp, seconded by Supervisor Hidahl

to:

- 1) Conceptually deny the Appeal by Adam and Amy Anderson;
- 2) Conceptually modify Special Use Permit S10-0009 for Villa Florentina Bed &Breakfast to remove

the ability to conduct special events, however allowing a stay of enforcement for the permitees' three existing contractual obligations under the terms of the original permit; and

3) Continue this matter to April 24, 2018 for final action and adoption of findings of fact consistent with the evidence presented.
