## DISCUSSION / BACKGROUND

Request to consider Conditional Use Permit S16-0008/Leaning Tree Lodge submitted by Cara Nelson to request a Bed & Breakfast Inn within an existing single-family dwelling and detached "bunkhouse", consisting of five guest rooms with a maximum occupancy of 10 people, excluding owners. Special Events, including amplified sound, are also requested for up to 150 guests for a maximum of 12 events per calendar year from 4 P.M. to 10 P.M. with amplified music occurring until

9:45 P.M. The property, identified by Assessor's Parcel Number 048-121-65, consisting of 10.61 acres, is located on the north side of Leaning Tree Road, approximately 400 feet west of the intersection with Lone Star Mine Road, in the Camino area, Supervisor District 3. (County Planner: Evan Mattes) (Negative Declaration prepared)\*
