This task force concept will increase the flow of information between law enforcement agencies and provide a highly trained and mobile specialized enforcement team.

Reason for Recommendation: The El Dorado County Sheriff's Office would like to participate in this task force and foresees a benefit to the citizens of the County of El Dorado by curbing the influx of drugs from surrounding counties as well as gleening revenues derived through potential asset seizures.
