## DISCUSSION / BACKGROUND

The Surveyor's Office received an application from, *Corporation of the Presiding Bishop of the Church Of Jesus Christ Of Latter Day Saints, A Utah Corporation Sole*, the owner of Assessor's Parcel Number 119-100-51 for an *Irrevocable Offer Of Dedication For Public Service Easement*. The offer is more particularly described in Exhibit "A" and depicted on Exhibit "B" attached and made a part of the Resolution. This dedication is in relation to the work on the Silver Dove Infrastructure and in support of the Bass Lake Specific Plan.

#### ALTERNATIVES

An alternative would be to not accept the Irrevocable Offer of Dedication. By utilizing this alternative, the County and/or developers would be unable to meet improvement obligations of the Bass Lake Specific Plan.

#### OTHER DEPARTMENT / AGENCY INVOLVEMENT

The Department of Transportation has reviewed said offer of dedication and supports the consent to the making of a recordation of said dedication.

#### CAO RECOMMENDATION

It is recommended that the Board approve this item.
