The attached draft responses have been prepared in the form prescribed by Penal Code section 933.05 and address the findings and recommendations of the Grand Jury which are under the jurisdiction of the Board of Supervisors.

The Final Response to the 2017-2018 Grand Jury Report will be submitted to the Presiding Judge of the Superior Court prior to September 20, 2018, and will be published on the County's website.
