FUNDING: General Fund. DISCUSSION / BACKGROUND

Each year in November, the Placerville Downtown Association hosts the Festival of Lights in downtown Placerville. The cost to the Downtown Association for hanging, removal, maintenance, and storage of the current decorations each year is \$5,000. The Placerville Downtown Association requested \$5,000 during the FY 2018-19 budget process, to be applied towards the purchase of new decorations for this event. The Board of Supervisors approved the request for \$5,000.

A funding agreement is required in order for the County to process the payment to the Placerville Downtown Association. Approval of the funding agreement also provides the finding that a public benefit is derived from supporting this event, which serves to gather the community and draw visitors into the County.
