### DISCUSSION / BACKGROUND

Surveyor's Office received an application from the Carolyn Marie Uchikura Trust Dated August 2009, for an Irrevocable Offer of Dedication (IOD) of a Road Right Of Way, including the underlying fee, and a Public Service Easement on Assessor's Parcel Number 119-100-60 (Formerly 119-100-57). Both easements are more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. The dedications are necessary for the improvements to Country Club Drive in support of the Bass Lake Specific Plan.

This offer shall remain in effect and run with the land until such time as the County of El Dorado Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution.

### ALTERNATIVES

An alternative would be to not accept these Offers of Dedication. By utilizing this alternative, the

County and/or developers would be unable to meet improvement obligations of the Bass Lake Specific Plan.

#### **OTHER DEPARTMENT / AGENCY INVOLVEMENT**

Transportation Department has reviewed said IOD and supports the consent to the making of this offer, subject to the condition that said Road Right Of Way and Public Service Easement will not be County maintained unless and until it has been accepted into the County maintained road system by Resolution of the Board of Supervisors.
