DISCUSSION / BACKGROUND

The County Surveyor's Office received an application from Ronald A. Ahlers and Jeannie P. Ahlers, for an Irrevocable Offer of Dedication (IOD 17-001), for Road Right-of-Way and Public Utility Easement, in order to meet Condition #29 of TM 05-1359 R/La Caille Estates Subdivision, imposed by the El Dorado County Department of Transportation. The condition requires the developer to obtain this Irrevocable Offer Of Dedication which is an offer is for an easement on Assessor's Parcel Number 070-072-96, and being more particularly described in Exhibit A and depicted on Exhibit B of the attached IOD. Authorization for recording said offer is pursuant to Government Code Section 7050. The parcel is identified as Tract 1 of Record of Survey, Book 24 at Page 19, at the Records Office, El Dorado County.

ALTERNATIVES

An alternative would be to not accept the IOD. By utilizing this alternative, the conditions for TM 05-1395R would remain unmet.
