The Surveyor's Office received an application from Serrano Associates, LLC, a Delaware Limited Liability Company, for a *GRANT OF DRAINAGE EASEMENT* on Assessor's Parcel Number 122-470 -15, and being more particularly described in Exhibit "A" and depicted on Exhibit "B" of the attached Exhibits. This offer is an Irrevocable Offer of Dedication (IOD) and is to remain in effect and run with the land until such time as the Board of Supervisors makes a finding of necessity for public purposes and accepts said offer by resolution and is in support of the Bass Lake Specific Plan.

#### **ALTERNATIVES**

An alternative would be to not accept the IOD. By utilizing this alternative, the County or developers, would be unable to meet improvement obligations on Hawk View Road for the Bass Lake Specific Plan.
